

TERMS AND CONDITIONS

1. The Parties

- 1.1. This site is operated by **VETERANS COMPENSATION COIN LTD**, a private limited company duly incorporated in the **UNITED KINGDOM (CRN: 12148729)**. The VCC activities offered by **VETERANS COMPENSATION COIN LTD**, including, but not limited to, its websites, forums, help desks, documentation, software, banking, payment system, wallets, and else (the "Services") may only be used for legal purposes.
- 1.2. Some jurisdictions may impose limitations on the use of cryptocurrency activities so users in those jurisdictions should consult with independent legal counsel before using the Victorum website. By using our website, you accept these Terms of Use ("Terms"), and the Services are offered subject to your acceptance, without modification, of all the Terms.
